

Appendix A: Better Practices to More Accurately Count Native American Students

Districts have two readily available mechanisms to produce more accurate counts of Native American students and improve school supports for Native American students.

The first is to identify American Indian/Alaska Native students through **inclusive** rather than exclusive reporting of existing racial/ethnic data. That is, districts can identify all students who check the box “American Indian/Alaska Native” regardless of what other boxes those students may have checked. Through data requests we made pursuant to the Public Records Act, we received student-level race and ethnicity data that allowed us to calculate exclusive and inclusive counts of American Indian/Alaska Native students for four California school districts. The table below shows that in all four districts responding to our request, the inclusive method produces far higher counts of American Indian /Alaska Native students than the exclusive method.

Districts can and should use this method not only to describe enrollment, but also to produce duplicated statistics on American Indian/Alaska Native students for key school accountability metrics such as graduation rates and suspension rates. These statistics would include students in the counts and percentages for all pertinent racial/ethnic categories, rather than privileging “Hispanic” and “Two or More” as exclusive master categories. For example, a student who identified on school forms as both “Hispanic” and “American Indian/Alaska Native” would appear in both the Hispanic duplicated graduation rate and the American Indian/Alaska Native duplicated graduation rate. This is already common practice in Minnesota school districts because the Minnesota Department of Education state data system uses this inclusive counting method for its districts to create a “state count” of American Indian/Alaska Native students.¹ Minnesota’s data system also has the capacity to collect more detailed ancestry/ethnicity information, including Tribal affiliation.²

The second mechanism to produce more accurate counts of Native American students is to proactively identify all students who are eligible to receive services under the federal Title VI Indian Education Formula Grant (Title VI) program and to report statistics on school accountability metrics for this group. Students eligible for this grant program include students with Tribal membership and students whose parents or grandparents have Tribal membership. Although this does not solve the statewide problem of significant undercounting, school districts can use more accurate identification of Native American students to more accurately measure student outcomes with add-ons to existing

data systems. Eureka City Schools in Humboldt County, California recently began entering demographic data from students' ED 506 forms using an add-on tool and is now able to run more precise reports on academic and equity metrics for its Native American students.

Appendix B compares school districts' exclusive counts of American Indian/Alaska Native students to their counts of Title VI-eligible students for districts receiving Title VI grants in 2022-23. Many of these districts show higher counts for Title VI grant-eligible students than for American Indian/Alaska Native students. For example, Bishop Unified School District in Inyo County reported 291 American Indian/Alaska Native students in 2022-23 but certified 537 students as eligible for Title VI grant services. Eureka City Schools annually reviews its list of students found eligible for Title VI grant services to ensure a more inclusive count of the district's Native American students, many of whom are categorized as "Two or More Races" according to the federal reporting of existing racial/ethnic data. The Education Northwest report, *Obscured Identities*, recommends several strategies for school districts to improve identification of Native American students, such as: better staff training on the value of the Title VI ED 506 Form and how to complete it; request detailed demographic information, including Tribal affiliation, on all standard school registration forms; and conduct comprehensive community outreach about Title VI programs and services to the broader school community.³

Some districts show lower counts for Title VI grant-eligible students than for American Indian/Alaska Native students. This may be due to higher numbers of students who are indigenous to Central or South American areas who are not eligible to receive Title VI services; or it may stem from districts experiencing confusion about students' Title VI eligibility. For example, Fresno Unified School District reported 520 American Indian/Alaska Native students but only 218 Title IV grant-eligible students in 2022-23.

Appendix B: Comparing School Districts’ Counts of American Indian/Alaska Native Students vs. Counts of Title VI-Eligible Students

Appendix B compares data counting American Indian/Alaska Native students in 69 school districts that received federal Title VI Indian Education Formula Grant (Title VI) program grants for school year 2022-23. The “CDE Count of AI/AN Students (Exclusive)” column lists the numbers of American Indian/Alaska Native students as collected according to the deeply flawed federal guidelines⁴ discussed previously in this report. The “Number of Students Eligible for IIEFG” column are the numbers of American Indian/Alaska Native students in each school district whom the district has identified as eligible to receive services under the Title VI program.

Appendix C: Methodology

The statistics presented in this report are intended as practical tools to support students, families, Tribes, educators, and community organizations to advocate for their school districts to better serve Native American students. The report compiles multiple school accountability metrics pertaining to students identified for reporting purposes as “American Indian/Alaska Native.” The sections below each pertain to a unique accountability metric, such as the school stability rate or suspensions, and each is associated with an appendix that includes data for every district in the state reporting on American Indian/Alaska Native students for that metric in the 2022-23 school year. Appendices D-J are designed to place this information readily at hand for advocates; the associated report sections are meant to show how the numbers can be used to call districts to task.

The sections below highlight districts that, according to state data, were failing their American Indian/Alaska Native students on one or more accountability metrics. Because of the flaws in data reporting around race/ethnicity described above, these statistics do not describe the full range of outcomes for Native American students. But these are the accountability metrics that the State intends to hold districts to task, and failures on these metrics clearly indicate the need for urgent conversations about how districts can better support Native American students. Where districts have adopted positive interventions to support Native American students, these accountability metrics may be used as a proxy to track progress over time, but the best measures of progress and success will account for all Native American students instead of relying on the exclusive American Indian/Alaska Native category.

This report utilizes data files from multiple sources. Each source is also associated with an online data tool that advocates can use to access the same statistics for other school years. The data sources include:

- California Assessment of Student Performance and Progress Research Files:⁵ These files contain the percentage of students in each school district meeting or exceeding grade level standards on the state’s Smarter Balanced Summative Assessments. Advocates can access statistics for their schools and districts at the CASPP website: <https://caaspp-elpac.ets.org/caaspp/>.
- California Department of Education (CDE) Downloadable Data Files:⁶ These files contain district-level statistics related to A-G completion, college and career readiness, graduation rates, suspensions, school stability, and chronic absenteeism. Advocates can access statistics for their schools and districts at the California Department of Education’s DataQuest website: <https://caaspp-elpac.ets.org/caaspp/>.
- The federal Civil Rights Data Collection:⁷ These files contain data pertaining to school staffing. Advocates can access statistics for their schools and districts at the Civil Rights Data Collection website: <https://civilrightsdata.ed.gov/about/crdc>.

DEFINITION: The “Smarter Balanced Summative Assessments” are comprehensive, end-of-year assessments for English language arts/literacy (ELA) and mathematics that are aligned with the Common Core State Standards for ELA and mathematics and measure progress toward college and career readiness. These assessments are administered to students in grades 3-8 and 11.⁸

DEFINITION: The “A-G Completion” metric shows the percentage of graduates in the four-year adjusted cohort who completed all A-G course requirements for admission into a University of California or California State University School with a grade of C or higher.⁹

All education data reported in this section pertain to the 2022-23 school year, except the data on school staffing from the Civil Rights Data Collection, which pertain to 2020-21, the most recent year of data reporting from that source available at the time this report was finalized. On January 17, 2025, the U.S. Department of Education released the Civil Rights Data Collection for the 2021-22 school year, available at <https://civilrightsdata.ed.gov/data>. Preliminary analysis by the U.S. Department of Education of this newer dataset is available at <https://www.ed.gov/media/document/2021-22-crdc-first-look-report>. We hope advocates can use this newer dataset in the future to continue advocating for better support for Native American students.

The CDE files redact data about any student subgroup with fewer than 11 students. Due to the chronic undercounting of and exclusive data reporting on American Indian/Alaska Native students discussed in the previous section, in most districts, American Indian/Alaska Native student populations are quite small. In 2022-23, only 0.49% of California students in the CDE data files were identified as American Indian/Alaska Native, and only 482 of 1,008 districts reported cumulative enrollments of 11 or more American Indian/Alaska Native students. In addition, the universe of districts reporting data on American Indian/Alaska Native students is even smaller for accountability metrics that pertain to only a few grade levels, such as test scores or graduation rates. In each section below, we are careful to state the number of districts with available data before presenting key statistics.

Because the ethnic and racial categories “Hispanic or Latino” and “Two or More Races” include and hide American Indian/Alaska Native students, we do not attempt to set up exclusive comparison groups. Instead, the sections below compare statistics for “American Indian/Alaska Native students” in a district to statistics for “all students” in that same district.

Appendix D: School Districts Reporting Smarter Balanced Summative Assessments Scores for American Indian/Alaska Native Students in 2022-23

The Smarter Balanced Summative Assessments (SBSA) are comprehensive, end-of-year assessments that measure whether California’s students are performing at grade level. We examined English language arts and math assessment scores for the 4th, 8th, and 11th grades, comparing American Indian/Alaska Native students to all students in their district and statewide. Two hundred eighty districts (out of a total 1,008 districts statewide) reported these rates for American Indian/Alaska Native students for school year 2022-23.

Appendix H: Suspension Rates for School Districts Reporting Rates for American Indian/Alaska Native Students

Defiance Suspension Rates: In the 2022-2023 school year, 79 California school districts suspended American Indian/Alaska Native students for “defiance,” defined in state law as “disrupt[ing] school activities or otherwise willfully def[y]ing the valid authority of supervisors, teachers, administrators, school officials, or other school personnel engaged in the performance of their duties.”¹³ Defiance is a highly subjective label used to vilify common low-level student behavioral issues like failing to follow directions or bring materials, wearing a hat in class, or talking back to a teacher.¹⁴

Appendix J: Chronic Absenteeism Rates for School Districts Reporting Rates for American Indian/Alaska Native Students

The Chronic Absenteeism Indicator represents the percentage of students who were absent for 10% or more of the instructional days they were enrolled to attend. Only students in grades K-8 are included in the indicator, and a student must be enrolled for at least 31 days to be included in the chronic absenteeism rate.¹⁶ 323 school districts (out of a total 1,008 districts statewide) that had 11 or more American Indian/Alaska Native students in this accountability metric reported chronic absenteeism rates for American Indian/Alaska Native students for school year 2022-23.
